

Mother's Day Campaign Terms and Conditions 2025

- The Mother's Day Spend and Redeem Campaign (**"Promotion"**) is valid from 2 May 2025 to 31 May 2025 (both dates inclusive) (the **"Promotion Period"**).
- The Promotion is open to participation of all Principal Cardholders ("Cardholders") only.
- By participating in the Promotion, Cardholders agree to be bound by these terms and conditions.
- The Promotion is valid for all DCS Personal Credit/Charge Cards, excluding DCS DeCard and D-Lite Cards.

Promotion Mechanics

- Redeem a Skylight Abalone Gift Set worth S\$228 ("Gift") with a minimum aggregated spend of S\$1,000 made during the Promotion Period.
- Each Skylight Abalone Gift Set includes:
 - Australia Superior Abalone (Restaurant Grade)
 - New Zealand Superior Abalone (Restaurant Grade)
 - Royal Dried Abalone with Black Truffles
 - Braised Dried Abalone in Superior Sauce
- Only eligible retail transactions posted during the Promotion Period will be considered for the Promotion.
- The redemption letter will, as far as commercially practicable and unless otherwise decided by DCS, be mailed to the eligible Cardholders' mailing address registered with DCS by 31 July 2025.
- Any reversals of transaction(s) posted during the Promotion Period will affect the minimum aggregated spend for the Promotion.
- Each Principal Cardmember may only redeem the Gift once.

How to Participate

- To participate in the Promotion, Principal Cardholders are required to send an SMS composed in the following format: "MDAY<space>Last 4 digits of your DCS Card number" to 8666 6362 from the mobile number registered with us ("DCS Registered Mobile Number").
- Only Principal Cardholders are eligible for participation in this Promotion, however supplementary cardholder spend can be included in the calculation of cumulative spend to the registered Card.
- Each Principal Cardholder is eligible to register only one (1) Card for the Promotion, regardless of the number of Cards held by the Cardholder.
- For avoidance of doubt, in the event of multiple SMS registrations by the Cardholder, only the latest SMS received by us will be taken as final.
- Only transactions made with the registered Card based on the last 4 digits of the DCS Card specified via SMS will count towards the Promotion.



- An acknowledgement of participation will be sent to the Cardholder's DCS Registered Mobile Number within one (1) working day.
- SMS participation begins on 2 May 2025 (Singapore time). The Promotion is limited only to the first 50 successful registered Cardholders.
- Cardholders whose current mobile number is different from DCS Registered Mobile Number are required to first update their mobile number with DCSCC before registering for the Promotion. Cardholders would not be eligible to participate should they register for the Promotion with a mobile number different from DCS Registered Mobile Number.
- Cardholders are only deemed to be successfully registered for the promotion upon receipt of the acknowledgment SMS from us.
